### APR Rates & Policies:

The APR may vary quarterly, based on the 13-week U.S. Government Treasury Bill as stated in the Wall Street Journal on the 10<sup>th</sup> of January, April, July and October, rounded to the next highest 0.25% plus a 9.99% margin. The APR will never be lower than 9.99%.

### Credit Card Lines:

A business may have multiple cards issued under its overall credit limit. However, each cardholder will have a separate card with a separate credit limit. The overall credit limit cannot be shared between cards.

### Annual Fee:

Low \$15.00 annual fee per credit card issued.

### Cash Advances:

- 3.00% fee per advance with a \$5.00 minimum.
- \$100.00 minimum advance, \$500.00 maximum advance.

### Other Fees:

**Late Fee:** \$30.00 fee when a required payment is not received by the due date.  
**Over Limit Fee:** \$25.00 fee for over limit usage.  
**Reissue Fee:** \$20.00 fee to reissue a lost or stolen card.  
**Returned Item:** \$30.00 fee if a payment is dishonored for any reason.

### Rewards Program:

Free rewards program to earn points by using your credit card. Points may be redeemed for a variety of rewards.

### Business Account:

The primary account for the business is required at DuTrac.
